**FILE Z00242-07 Barlow Trail Park**  
Discussion: Hearing is scheduled for 6/14 for 8-space parking lot that will include kiosks and signage

**FILE Z0288-07 Todd Iseline, Zig Zag Store, applicant**  
Discussion: Reviewed and discussed planned reopening of historic general store. Owner was present at meeting. A hearing is scheduled on 6/14. Discussed stabilization of ground and restoration of vegetation.

**FILE Z0326-07 Malcolm and Janeen McAninch, applicants**  
Discussion: Reviewed and discussed approval with conditions of PRCA application for single family residence on E. Lolo Pass Road. This is a flood damage claim. Owners are present as well as John Borge, representing the county. Discussed process for addressing flood damage, tight comment and work periods. Also broadly discussed other flood damage activities in the area and what community can expect.

### **NEW BUSINESS**

**FILE Z0332-07 Leonard Kirschner, applicant**  
Discussion: Reviewed and discussed application for temporary housing near Barlow Trail Road and Sandy River Lane. This is a temporary siting of a manufactured home on 2.73 acres for care of applicant's mother. Meets all requirements.

Action: CPO voted to recommend approval of application: 17 yes, 0 no, and 1 abstain.

Discussion: Reviewed and discussed PRCA application for two single family residences on Relton Road. Two neighbors are present. There is significant concern about: potential flood hazard to neighboring properties; that property is a natural wetland; and that setbacks are inaccurately represented on the application. Because this falls under the PRCA, it will require an onsite visit from a County planner.

Action: CPO Chair Don Mench will meet with County planner on site visit to discuss concerns. Neighbors will continue to talk with the County about concerns.

**FILE Z0354-07** **Braun/Olson, applicants**

Discussion: Reviewed and discussed PRCA application for single family residence on .58 acres on Relton Road. This file was discussed along with Cliff applications above. Property is on North side of Relton Road, away from River.

Action: The CPO will submit comment that County solicit and respond to concerns from adjoining property owners. Comment will also recommend restoration of native vegetation.
